At the same time, the law "On the basis of the state youth policy in the Republic of Uzbekistan" was adopted in our country on November 20, 1991 and came into force on 1 January 1992. This Law

was in force until September 14, 2016, when the Law on State Youth Policy was adopted. Certainly, creation of great opportunities for the free development, education and upbringing of our children is explained by the fact that in our country the interests of young people are raised to the level of state policy. Therefore, legal protection of the rights and interests of young people in the spiritual, cultural, spiritual and cultural life of the country has been identified from the very first days of independence.

MATERIALS AND METHODS

In the late 1980s and early 1990s, the country was given the utmost attention to the protection of young people from all kinds of iodine ideas and their comprehensive knowledge and professional development. It is well known that in 1999 the UN General Assembly supported the initiative of the Minister of Youth Affairs at the 1998 International Conference in Lisbon - declaring August 12 as the International Youth Day. This document outlines measures to further strengthen the activities of states in the field of youth. The program of action includes 15 directions. Education, employment, hunger and poverty, health, environment, drug abuse, juvenile delinquency, meaningful organization of youth leisure, girls and young women, community and decisionmaking, globalization, information - communication technologies, AIDS and infectious diseases, armed conflicts, and intergenerational relationships. In June

this year, the President of the Republic of Uzbekistan adopted the Decree "On increasing the effectiveness of the state youth policy and support for the activities of the Youth Union of Uzbekistan". The Decree is a logical and gradual continuation of existing laws and regulations that directly affect youth. According to it, the Youth Union of Uzbekistan was created on the basis of the Kamolot Youth Social Movement of Uzbekistan for the consistent and effective implementation of the state youth policy and radical reforming of this sphere. At the same time, the day of establishment of the Youth Union of Uzbekistan - June 30 is annually celebrated in our country as the Youth Day. Indeed, intellectually and spiritually mature young people today play a significant role in the development of state and society to a new level, in the development of society and further development of the processes of modernization of the country. It should be noted that in the framework of the most important issues that should be addressed in the Strategy of Action for the five priority areas of development of the Republic of Uzbekistan in 2017-2021, the tasks that are in the interests of young people are defined. In particular, the Strategy of Action focuses on the development of physically sound, mentally and mentally developed, independently thinking young generation in the implementation of tasks aimed at improving the state youth policy. Increasing social activity of youth, their employment and involvement in entrepreneurship, support and realization of their creative and intellectual potential, healthy life with a focus on physical education and sports. Most importantly, today, new approaches and approaches for addressing the issues of youth require the targeted use of public authorities and educational institutions, educational institutions, law enforcement agencies and other organizations directly working with young people. Extensive work is being done in our country in the field of state youth policy. In the past, a special system has been created to support young people, protect their rights and legitimate interests, and bring up enterprising and courageous young people who are able to take responsibility for the future of our country.

The Agency for Youth Affairs of the Republic of Uzbekistan, Youth Parliaments under the Chambers of the Oliy Majlis, the Youth Academy under the Ministry of Innovative Development of the Republic of Uzbekistan were established. "Project Factory" has started operating in the regions. Ensuring the healthy growth, quality education and harmonious development of the younger generation, as well as the development of young people's interest in culture, art, sports, information technology and reading. Efficient work is underway to implement the "Five Important Initiatives" to support New state and non-state preschool educational institutions, secondary schools, higher education institutions, branches of prestigious foreign universities, modern IT parks, cultural institutions and sports facilities, completely new educational institutions - "President schools "," Temurbeklar Maktabi "," Ijod Maktabi "serve to educate a new generation of competitive personnel in today's globalized world. In order to radically reform and further develop the youth support system, 2021 has been declared the Year of Youth Support and Public Health in our country. Development of effective solutions to problems in the field of youth, as well as bringing to a new level of state youth policy, stated at the Youth Forum of Uzbekistan in December 2020 and the Address of the President of the Republic of Uzbekistan to the Oliy Majlis and the people on December 29, 2020 In the Concept of Development of State Youth Policy in Uzbekistan until 2025, adopted by the Cabinet of Ministers in order to ensure the implementation of tasks related to:

-improvement of the legal framework aimed at protecting the legitimate rights and interests of young people;

-increasing the role of youth in ensuring security, environmental stability, justice and equality in the country;

-improvement of conditions for access to qualified medical services for young people, increase medical literacy among them and promote a healthy lifestyle;

- Ensuring quality education for young people at all levels of education, creating conditions for the development of inclusive education in the regions;

-education of young people in the spirit of love and devotion to the motherland, family, the idea of independence, respect for national and universal values;

- expanding the economic rights and opportunities of young people by creating decent working conditions and protecting their legal labor rights;

- Implementation of the "Five Important Initiatives" aimed at attracting young people to culture, arts, physical culture and sports, the formation of skills in the use of information technology among young people, the promotion of reading among them, the employment of women increase;

- support for young people in need of social protection, people with disabilities, children raised in orphanages, orphans, children who have lost their breadwinners and are deprived of parental care;

-support and train young professionals for civil service, ensure their competitiveness in the labor market;

-implementation of systemic measures aimed at expanding the rights and opportunities of young women, further enhancing their status in society;

-support the activities of youth organizations and volunteers in order to implement the ideas, proposals and initiatives of young people;

- further improvement of the system of work with compatriots abroad, cooperation with international youth organizations and exchange of experience in the international arena;

Uzbekistan has approved a "road map" for the implementation of the concept of development of state youth policy until 2025 in 2021-2022.

RESULT AND DISCUSSION

Currently, the opportunities created for young people in our country are very wide. As a result of the reforms carried out in recent years, a comprehensive system of youth support has been created in our country. The upbringing of educated, broad-minded patriotic young men and women has been identified as one of the priorities of state policy. Young people are approached not as a problem, but as the main driver of development, an active participant in socioeconomic development, a bold initiator of new ideas, the backbone and backbone of our people.

In order to bring the state youth policy in Uzbekistan to a new level, to find solutions to problems in the field, to effectively organize and coordinate the activities of the competent authorities, in 2020 a state body - the Agency for Youth Affairs was established.

An integrated infrastructure has been created to implement programs aimed at solving problems in areas and areas related to youth. In particular, the Committee on Youth, Culture and Sports was established in the Senate of the Oliy Majlis, and the Commission on Youth Affairs was established in the Legislative Chamber of the Oliy Majlis.

The Youth Academy was established under the Ministry of Innovative Development. The Association of Volunteers of Uzbekistan, the first of its kind in the country, has brought together more than 70 volunteer groups from across the country. The World Youth Association of Uzbekistan was established to establish regular contacts with our young people studying and working abroad, to protect and support their rights and interests.

According to the United Nations Youth Agenda 2030, creating opportunities for young people to receive quality education is a priority for all nations. As a result of large-scale reforms in the education system in our country, the President, creative and specialized schools have been established.

Over the past five years, the number of higher education institutions has doubled, from 77 in 2016 to 141, and the quota for admission to higher education has been tripled to 28 percent. It is worth noting that additional opportunities have been created for young women to study, and special grants have been allocated for more than 3,000 girls.

The Presidential Grant for the 200 young people who scored the highest in the entrance exams to higher education institutions, as well as the introduction of Presidential and state scholarships for undergraduate students of foreign universities in our country, gave even more incentives to talented people.

It should be noted that the National Human Rights Center of the Republic of Uzbekistan in cooperation with educational institutions conducts seminars and talks with students and listeners on the topics of youth rights and obligations to enhance the legal culture of youth. For example, during a series of discussions at the Ministry of Internal Affairs on the topic of "Cooperation of Judicial Laws with Civil Institutions in Increasing the Legal Activity of Citizens" at the High School of Fire Safety, the Prosecutor General's Office of the Republic of Uzbekistan with a special emphasis on the prevention of offenses and criminality, especially in the minds of the younger generation, commitment to the Motherland, courage and courage. The discussion centered on topical issues such as the formation of a sense of belonging to the nation and nation's development. In care of young people, we must always remember that it is our human duty to safeguard them against the negative effects of popular culture, the aggressive ideas of the Internet and vicious forces, and the effects of such extremism as religious extremism and terrorism and separatism. The important thing is to use our young people wisely, as well as the opportunities created for them today, not only because they have a clear understanding of the rights and responsibilities of the youth, but also to avoid emancipation. The deputy mayors of regional and district administrations on youth policy, social development and spiritual and educational affairs, and deputy heads of district police departments will be appointed upon the recommendation of the Youth Union of Uzbekistan. The officer holding this position is more effective in implementing youth policy on the ground to be successful, you need to be a dedicated, initiative person, who can lead young people, and who can safely lead any problem to the discussion space.
